








# Recommendations for Dental Hygienists During COVID-19 Outbreak



COVID-19 is impacting the dental profession. As primary oral health care providers, dental hygienists are potentially at risk of contracting the virus. This document will help dental hygienists to mitigate the risk.

### Possible transmission routes for COVID-19 in dental clinics

- Studies have shown that the COVID-19 virus is present in saliva.
- Procedures such as ultrasonic scaling and air polishing create aerosols that may be contaminated with the virus.
- Common transmission routes are direct transmission (inhalation of respiratory droplets produced during coughing or sneezing) and contact transmission (touching surfaces that have been contaminated by droplets or aerosols and then touching one's face).

### Client screening procedure

Screen clients prior to their appointments, both when confirming and in-office:

- Ask whether they have travelled or been in contact with someone who has travelled outside Canada in the last 21 days. Reschedule the appointment as required.
- Remind clients that if they have flu-like symptoms, such as fever, cough or difficulty breathing, they should cancel/reschedule their appointments and see a medical professional.
- Ensure hand sanitizer is available at the front desk and encourage its use by all clients upon arrival.

### Infection control protocols

- · Aerosol reduction:
  - Have clients rinse with antibacterial mouth rinse prior to treatment
  - Use high-volume suction during aerosol-producing procedures
- · Personal protective equipment:
  - Safety glasses
  - Gloves
  - Masks: minimum one mask per client
     ""(see risk assessment guidelines below)
  - Gowns
  - Face shield when performing aerosol-producing tasks
- Risk assessment guidelines for mask usage (to address mask shortage):
  - Level 1 mask: use when minimal fluids, spatter or aerosols are produced, e.g., intraoral exams, taking impressions, taking radiographs, sanitizing the operatory. Can also be used in conjunction with a full-face shield when scaling with an ultrasonic and air polishing.
  - Level 2 mask: use when moderate fluids, spatter
    or aerosols will be produced, e.g., scaling and root
    planing with hand instruments. Can also be used in
    conjunction with a full-face shield when scaling with
    an ultrasonic and air polishing.
  - Level 3 mask: use when moderate to heavy fluids, spatter or aerosols will be produced, e.g., ultrasonic scaling and air polishing

\*\*\*The layering of lower level masks for added protection is not recommended by public health experts.

Follow standard infection prevention and control protocols for sanitizing the operatory. In addition, disinfect public areas in the dental office regularly throughout the day. This includes door handles, counters, desks, tables, and chairs.

### College of Dental Hygienists of Manitoba

With Spring around the corner promising new growth, it is a great time to ponder new directions. While reviewing a number of articles, somewhat surprisingly, it seems our 'directions' for the profession of dental hygiene today are not much different than they were 15-20 years ago. I came across a one-pager that MDHA circulated sometime in 2001. The call to action at that time was "legislation that would provide Manitobans with safe, competent, quality oral health services" and "more importantly better access to those services". While a huge milestone accomplished in 2008 when self-regulation was achieved for dental hygienists in Manitoba under the Dental Hygienist's Act, there remains a limiting scope of practice and site restrictions which prevent hygienists from providing care for all Manitobans.

The greatest gaps in care exist in our rural and northern communities. It is now 2020 and we are working towards new legislation under the Regulated Health Professions Act (RHPA) which will further enable dental hygienists to provide Manitobans with safe, competent, quality oral health services.

I also came across an American Dental Hygienists Association (ADHA) article from 2005, titled, 'Focus on Advancing the Profession'. The article described how they had engaged with their members and determined that dental hygienists across their country shared a number of fundamental beliefs that should shape the focus and vision for the future of dental hygiene. It is interesting to note these eight fundamental beliefs, articulated in 2005, are very similar to the future directions that are considered important pursuits in 2020 for dental hygienists in Manitoba.

The eight beliefs listed in the ADHA article are as follows:

- Access to oral health care is a right of all people
- Health needs of the population is growing, dental hygiene practice and education must evolve to meet them
- Dental hygienist should be able to provide the care they have been educated to deliver
- Dental hygiene is part of an overall health care delivery system; dental hygiene must create an integrated model of oral health care delivery with other health care providers
- Barriers that restrict the public's access to oral health care must be identified and removed.
- Dental hygiene must move from a mechanicalbased treatment of disease model to a wellness model of care
- Dental hygienists advocate high standards of professional practice
- Dental hygienists should be responsible for determining their future education, licensure and practice, including expanding the profession's research base It is clear the growth of our profession is a journey and there are still fundamental changes that need to occur if we are to provide safe, competent dental hygiene care to all Manitobans.

Thank-you to all of you who completed the recent survey; the results of which will form an integral part of our Reserved Acts submission to government. The College continues to work with MDHA as a collaborative partner in the pursuit of more accessible dental hygiene care for all Manitobans.


